# R.A.O.U. Individual Observation Point Scheme

#### INTRODUCTION

The Individual Observation Point (I.O.P.) scheme is designed to give information about the migration and other movements of our birds, and about the fluctuations in their population levels. The R.A.O.U. intends to start the scheme, initially restricting it to Southern Victoria and Tasmania, i.e., to those areas most directly concerned with trans-Bass Strait migration.

The success of such a scheme is entirely dependent on amateur participants and the Council of the R.A.O.U. hopes that as many observers as possible, living within the specified areas, will join the scheme.

#### Метнор

Each observer counts the birds in an observation area of his own choice—his own garden, a piece of agricultural land, a school ground, a park, etc. The counts are made, preferably, daily, but in any event not less than four times a week.

The results of the counts are entered on special forms provided, one for birds found in the area and a second for birds observed flying over the area. The counts may be complete counts of a specified area or strip counts (transects). It is essential, however, that each observer is strictly consistent with his method from day to day.

#### ADMINISTRATION

The R.A.O.U. scheme is to be administered from Hobart. Mr D. G. Thomas will be responsible for issuing instructions and record forms, and for maintaining the collection of completed forms. It is hoped that a monthly news letter will be circulated to participants, and an annual report will be published.

Please consider very carefully whether you can participate in the scheme. The full potential of the scheme can only be realised if sufficient observers participate fully. The Council, therefore urges all observers living in Southern Victoria and Tasmania to support the scheme. Mr Thomas will be pleased to advise, help and encourage.

(1) Validation of the generic name Cacatua Vieillot, 1817 (Aves). Z.N.(S.) 1647.

Any zoologist who wishes to comment on the above case should do so in writing, and in duplicate, as soon as possible, and in any case before 13th February, 1966. Each comment should bear the reference number of the case in question. Comments received early enough will be published in the Bulletin of Zoological Nomenclature.
