Interview Guide

1. What's your highest level of education? 2. What country were you born in? 3. Do you recall your child having their height and weight measurements are taken when they visited a health service in SWSLHD? **Probes:** If the answer is no, remind the parent where the measurement took place. If they still do not remember or their parent not present at the time of measurement, proceed to question 5 4. Can you remember where the measurement was taken? **Probes**: - How private was the space that the measurements were taken in? If not private, ask if this bothered them - Can you remember which health professional took the measurements? 5. How did you feel about having your child measured? Probe: - Were you surprised/pleased/offended that your child's height and weight were measured? - Why did you feel like that? 6. What did the health professional say about your child's BMI results? **Probe**: how did you feel about the way they discussed it. – why did you feel like that... 7. Before your child had height and weight measured, did you think your child's weight was underweight, about right, or overweight? 8. Did having your child's height and weight measured change your view? 9. Has any other health professional discussed your child's weight before? **Probe**: who discussed this with you (eg, GP, paediatrician, nurse etc)? 10. What information were you given about healthy habits like eating, exercise, and sleep? **Probe**: Was it verbal only, written only or both, was it helpful)? 11. What would be the most useful thing HCP could do or say to address a child's weight? 12. What would be the least useful thing HCP could do or say to address a child's weight? 13. What else do you need from HCP's in order to help improve your child's eating and exercise habits? 14. What changes have you attempted to make to your child's lifestyle since that measurement? How successful have you been? 15. Where you referred to anyone to help you with your child's weight and exercise? 16. That's the end of my questions thank you for your time is there anything else you would like to say that we may not cover already.
