Legislation

The titles of Acts, Ordinances, Regulations etc., should be cited within the text. Generally, in-text citations often give people all the information they need, so legislation does not need to be included in the reference list unless important to an understanding of the work. The first citation should always be cited exactly and in full and formatted in italics. If not immediately obvious from the context, the jurisdiction (Commonwealth, Victoria, NSW etc.) should be stated at the end in parentheses and formatted in roman font. All subsequent citations can use a descriptive title formatted in roman font without a date.

e.g. first in-text citation: Aged Care (Living Longer Living Better) Act 2013 (Cth); subsequent intext citations: Aged Care (Living Longer Living Better) Act e.g. first in-text citation: Mental Health Act 2014 (Vic); subsequent in-text citations: Mental Health Act

Unpublished material

Work that has not been published or accepted for publication should not be included in the reference list; this includes internal communications and internal reports not available to the public. Works that are available online are considered 'published'. Work not published may be cited in the body of text.

e.g. work not published: (K. Evans and B. Gibson, unpubl. data) e.g. internal communications: (A. E. Martell, R. M. Smith and R. J. Motekaitis, pers. comm.)

Software

Software should not be included in the reference list. Details of software used for analysis should be included as an in-text citation to the program, version number and manufacturer/company name (e.g. SPSS Version 26.0; IBM Corp). Specific sections or pages of the software manual, if important to an understanding of the work, may be included in the reference list. The exception to this rule is R, which can be included in the reference list.
